

## **Agreement of the Project Management Institute, Inc.**

This Agreement made this \_\_\_\_ of \_\_\_\_\_, 2005, by and between \_\_\_\_\_ (hereinafter "Author" or "Authors" [each author must execute this Agreement]) the Project Management Institute, Inc. as the publisher (hereinafter "Publisher"), and Frank T. Anbari, a faculty member at The George Washington University, as the Editor (hereinafter "Editor").

1. Author(s), \_\_\_\_\_, hereby grants Publisher and Editor the right to, including, but not limited to, all rights to adapt, display, modify, publish, license, translate and distribute in any form or medium whatsoever without limitation derivative works from the case(s) entitled: \_\_\_\_\_ including all abstracts, summaries, figures, charts, illustrations, artwork and graphics in connection with the case or cases (hereinafter "cases"), in any periodical, paper or work published by Publisher.
2. Author(s) permits the Publisher to grant others permission to photocopy or otherwise reproduce any and all portions of the derivative work case(s).
3. Author(s) grant Publisher the right to Publish the derivative work case(s) in print, electronic, digital formats and any other formats that become available.
4. Author (s) grants Publisher and Editor a non-exclusive license. Author(s) shall retain the copyright, interest and title in their original case(s). PMI shall retain the copyright, interest and title in those portions of the derivative work cases(s) that are the wholly original creations of PMI.
5. Author(s) represent(s) and warrant(s) that he/she has full power and authority to enter into this Agreement and does so voluntarily.
6. Author(s) represent(s) and warrant(s) that the information contained in the case(s) is/are based on publicly available documents, Internet sources, Publisher publications, information obtained from the project team of the subject case, other research sources, or original with him/her/them and to the best of the Author(s) knowledge, does not infringe the statutory copyright or common law literary rights of others, or violate the rights of privacy of others, or libel of other persons.
7. Author(s) agree(s) to indemnify and hold harmless the Publisher in any action arising out of facts, which constitute a breach of the foregoing representation and warranties.
8. Publisher shall provide each of the authors and supervising professor, with one copy of each of the cases published in 2003-2004 (at least six cases) for his/her personal use and to pursue personal Professional Development Units (PDUs) from PMI(R), for those cases that they did not originally author, contingent on PMI offering PDUs for the completion of the derivative works. These will be offered at no charge.
9. PMI(R) shall show the editor's name and his affiliation with The George Washington University on the cover page of each Case Study and Teaching Note, and the names of the editor, authors, and supervising professor, and a paragraph referencing The George Washington University on the following page of each Case Study and Teaching Note.

This shall apply to any publication of the case(s) in any periodical, paper, print, electronic or digital formats.

10. This Agreement will commence and become effective on the date it is signed by the Author(s). A facsimile copy of this Agreement to any facsimile signature, or electronic signature will be treated as an original. This Agreement will be binding upon the heirs, successors, executors, administrators, legal representatives, affiliates and assigns of the parties.
